Monitoring Requirements Not Met for GA1270000 BRUNSWICK

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. We did not complete the required monitoring or testing for LEAD & COPPER that was due during the 1/1/2014-12/31/2016 compliance period and therefore cannot be sure of the quality of your drinking water during the last compliance period.

What should You do? There is nothing you need to do at this time.
