# MINUTES

Chairman Sammons called the meeting to order and provided the invocation.

Chairman Sammons requested that the order of the Agenda be changed to allow for the discussion items to be heard first.

#### DISCUSSION

#### 1. Creek Side Update

Mr. Keith Morgan stated that the sewer line was complete and ready for service. Mr. Morgan advised the Commission that the JWSC was still not sure how many of the homes would be required to tie on. Mr. Bill Jenkins from Environmental Health stated that approximately 9 to 11 of the 38 homes are considered to be in failure and will be required to tie on to sewer.

Mr. Gerald Rushing, one of the duplex owners, stated that he was interested in knowing what the costs are going to be to connect his units to sewer. Mr. Rushing stated he feels the County should waive the tap fees.

Chairman Sammons reviewed the history of the problem and explained how the JWSC has assisted the homeowners by funding the installation of the sewer line to the subdivision.

## 2. Financial Update

Mr. John Donaghy advised the Commission that the auditors are actively working and have requested that all accounts be frozen until they have finished their review. The auditors are waiting on confirmation from the City and County on funds transferred 12/31/07.

Mr. Donaghy stated that an RFP for Debt Collection is currently out for bid and posted on the web site.

Mr. Donaghy updated the Commission on the search for a Customer Service Supervisor and stated that an offer would be made in the next couple of days.

## 2. Assignment of New Cingular Wireless PCS Tower and Ground Lease Agreement

Commissioner Sublett made a motion that was seconded by Commissioner Thompson to approve the assignment of the tower and ground lease agreement with New Cingular Wireless PCS, LLC. Motion approved 5-0.

## 3. Minutes of the September 4, 2009 Meeting

Motion was made by Commissioner Brooks and seconded by Commissioner Thompson to approve the minutes of the September 4, 2009 meeting. Motion carried 5-0.
