### INVITATION FOR BIDS

Sealed bids for **CANAL CROSSING PUMP STATION PROJECT, BRUNSWICK, GEORGIA** will be received by the Brunswick-Glynn County Joint Water and Sewer Commission (JWSC) at the JWSC's Office of the Director, 700 Gloucester Street, Suite 300, Brunswick, Georgia 31520 until **3:00 p.m. local time, July 30, 2015** at which time and place they will be publically opened and read aloud.

Plans, specifications and bidding documents are on file at the JWSC Main Office, 700 Gloucester Street, Suite 300, Brunswick, GA 31520. Copies may be obtained at the same address by contacting Elizabeth Burns at the JWSC (Phone: 912-261-7126; E-mail: [eburns@bgjwsc.org](mailto:eburns@bgjwsc.org)) upon payment of a non-refundable one hundred fifty dollars (**\$150.00**) for each set of documents requested. The documents are also available electronically (CD) free of charge.

The work to be performed under this contract consists of furnishing all labor, materials, tools, equipment and incidentals required to construct complete in place and ready to operate a new Wastewater Pumping Station and associated force main. More specifically the work includes, but is not limited to:

- Security fencing, gravel access road and related site work
- Erosion and sedimentation controls
- New precast concrete wetwell with aluminum access covers
- Pumping equipment and accessories
- Electrical work including controls and SCADA
- Discharge piping, valves, effluent flow meter, etc.
- Six (6) inch PVC forcemain with associated fittings and appurtenances

The Bidder is **encouraged** to examine the location of the work and inform himself fully as to the conditions present at the site. A **mandatory pre-bid meeting** will be held in the JWSC main conference room, 700 Gloucester Street, Suite 300, Brunswick, Georgia 31520 on **July 15, 2015, at 11:00 a.m. local time** followed by a site visit for anyone interested in attending.

A bid guarantee in an amount not less than five percent (5%) of the amount bid must accompany each bid. Acceptable forms of bid guarantees are: a bid bond, certified check or cashier's check made payable to the Brunswick-Glynn County Joint Water and Sewer Commission. Performance and Payment bonds, each in an amount equal to hundred percent (100%) of the contract amount will be required of the successful Bidder.
