The meeting is being publicized on the radio, newspaper, and individual notifications to over 150 businesses in the area.

York Phillips has been asked to advise the date of the next meeting of the Belle Pointe Home Owners Association so the JWSC can meet with the residents. Chairman Dean stated Glyndale is another area for potential growth of the system.
