Specifications

1. Bid Form

The Bid Form has been modified to update changed quantities for items related to the reroute of the 16-inch forcemain into the Dunbar Creek WPCP, to address and clarify additional tree removal, and to include rehabilitation of an existing manhole at Dunbar Creek WPCP.

The Bid Form has been modified in its entirety and is included in the Addendum documents.

2. Section 01025: Measurement and Payment

Section 01025: Measurement and Payment specification has been updated to include and clarify measurement and payment information for the following items in 1.06:

- O. Rehabilitate Existing Manhole at Dunbar Creek WPCP (added).
- T. Tree Removal (Frederica Road and Palmetto Street) (clarification regarding assistance from GA Power).
- U. Tree Removal (East of Dunbar Creek WPCP Entrance) (added).

2. MOT-G2: "G" Drill Segment MOT and Pipe Staging West Pullback

The forcemain route on drawing MOT-G2 has been modified to the east of the Dunbar Creek WPCP entrance including a revised location of the pullback pit. The "G" West Pullback Notes have been revised to account for pullback pit location change.

3. EC-11: Erosion Control Plan

8. C-23: WPCP Entrance Plan and Profile from Sta: 0+00 to Sta: 2+60

9. C-23A: Inset Plan WPCP Updates

10. C-23B: Construction Staging Area
