THIS ADDENDUM IS FOR THE PURPOSE OF MAKING THE FOLLOWING CHANGES OR CLARIFICATIONS:

PROJECT CLARIFICATIONS AND PRE-BID CONFERENCE NOTES

1. Extension of Bid Due Date

Bid due date is being extended to **Wednesday, May 10, 2017 - NOON**. This change is being made in consideration of delays in material pre-purchase requirements associated with fittings that will be ordered and provided by BGJWSC to selected contractor.

2. Pre purchase of materials – UPDATE

BGJWSC staff received approval on 4/6/2017 to move forward with a pre-purchase of 3,300 linear feet of 24" HDPE pipe to be delivered at a specific date sometime after 6/20/2017 to selected bidders laydown area.

Based on pre-bid attendee feedback it has been suggested that additional items with long lead times such as the air release valves, vault structure, fittings, etc. should be considered for pre-purchase in order to meet project completion targets.

Follow up: BGJWSC staff has compiled the list and received quotations. In this process, it was confirmed that (4) items will have significant lead time of 12+ weeks.

The final list will be approved by JWSC commission and new bid form reflecting these changes will be posted no later than 4/28/2017.

3. Extension of Due Date for Section 02750 – Horizontal Directional Drilling Contractor Pre-qualification Application – Thursday, April 27, 2017 at 5:00 p.m.

Due to the change in anticipated project start date, BJGWSC will re-open and extend the prequalification period for HDD prequalification application to Tuesday, 4/25/2017 at 5:00 p.m. This will allow any bidders who may have been constrained by the original timeline the opportunity to submit a pre-qualification application and if deemed qualified, a bid on the new bid due date of Friday, May 4, 2017 at NOON.

A list of pre-qualified bidders eligible to submit a bid on this project will be posted no later than **Monday, May 1, 2017 at 5:00 p.m.**

4. Extension to overall Contract Length

Due to the lead time of the fittings required for this project, a provision of additional contract time up to (30) days may be added at BGJWSC's discretion. This determination will be made at the time of pre-construction meeting, when a confirmed delivery date has been provided by the fittings supplier.

5. Order of Construction - UPDATE

Construction shall begin at Station 0+00 and proceed along Fifth Street towards LS 4005. The intent is to place LS 4005 on the new 24-inch force main as soon as possible.

The order of construction remains unchanged.
