On December 29, 2017, staff celebrated the retirement of Billy Simmons, Water Production Superintendent, following 35 years of dedicated service to the community.



# Changes to Capital Improvement Fees Considered

Seven of the businesses the Mainland Planning Commission approved site plans for at its Tuesday meeting are "reconsidering their commitment to moving forward in Glynn County" after seeing the tap-in fees charged by the water and sewer utility. That was the lede to an article published in The Brunswick News on November 20, 2017. The public, developers, small business owners, and politicians alike have voiced their collective frustration with this situation to staff members and commissioners of the JWSC. The Commissioners of the JWSC requested that staff take a deeper look into the situation to see if any options were available.

The JWSC adopted the current model for calculating Capital Improvement Fees (CIFs) beginning July 1, 2017.

The JWSC utilizes CIFs to pay for expansion projects that allow us to better serve our current customer base as well as provide adequate capacity for new customers. These are substantial needs as outlined in the JWSC Master Plan. However, for potential commercial and multi-family residential customers, these fees have proven onerous.

Upon looking at different options, staff arrived at five new options for calculating CIFs. Due to space considerations, please refer to the JWSC's Facebook page and YouTube channel for the Special Called Workshop of January 17, 2018 should you want more details of the options presented. None of these options are perfect, but all of them manage to provide some relief to potential commercial and industrial customers that want to com-

mit to Brunswick and Glynn County. The JWSC will vote on a potential solution to the CIF situation on February 1, which unfortunately is before many of you will have a chance to read this newsletter. There are no guarantees at this time that the fees will change, as a vote of the IWSC Commissioners is required for any changes to occur. However, the JWSC staff is working diligently to help solve this issue and many more that our customers have brought to our attention. Staff hopes that this is the first step to providing greater support for the economic well-being of Brunswick and Glynn County, so that the Golden Isles becomes an even more attractive community to live, work, and visit.
