THIS ADDENDUM IS FOR THE PURPOSE OF ANSWERING THE FOLLOWING QUESTIONS:

1) QUESTION: Please define what the JWSC means by "bi-weekly" services? Would this mean every other week or twice a month? Several months have 5 weeks.

ANSWER: JWSC defines bi-weekly as every other week. Payment will be processed on a monthly basis. Please structure your proposals accordingly.

2) QUESTION: Under Scope of Work, #6 Mulch it is not listed on the service cost schedule so does this mean it is an extra charge?

ANSWER: Mulch cost should be included in your proposal. In addition, straw will be needed once a year at the Main Administration Building. Mulch will be needed twice a year at the following locations:

- Main Administration Building 1703 Gloucester Street, Brunswick GA, 31520
- Exit 29 Southport Treatment Plant 391 Southport Parkway, Brunswick GA, 31523

- Academy Creek Treatment Plant 2909 Newcastle Street, Brunswick GA, 31520
- 3) QUESTION: There is no mention of insecticide or herbicide weed spray on the service cost schedule. Does that mean this is not wanted/required?

ANSWER: Yes, please include cost for insecticide and herbicide weed killer in your proposals.

4) QUESTION: Can you please confirm that physical attendance is NOT necessary at the March 18, 2020 mandatory pre-bid meeting?
