THIS ADDENDUM IS FOR THE PURPOSE OF ANSWERING THE FOLLOWING OUESTIONS:

1) QUESTION: Are there any erosion control drawings for this project?

ANSWER: There are no E&S plans for this project. The Contractor is advised to follow Best Management Practices as outlined in the NPDES and GSWCC.

2) QUESTION: Can any of this project be directionally drilled in lieu of open cut?

ANSWER: The JWSC does not object to directional drill, however the Contractor will need to maintain the depth specified on the drawings so as not to create additional low and high spots in the forcemain to warrant installation of any additional ARVs, and maintain access for ease of repairs.

3) QUESTION: Can 30 days be added for final documents and asbuilts? 60 days is very tight to complete the project and have Final Asbuilts ready for submission.

ANSWER: 60 days should be maintained for substantial completion; meaning the forcemain installation completed and tested, is functional and ready for connection to Pump Station 4116. An additional 30 days could be added for minor punchlist items and record drawings or closeout docs.

4) QUESTION: How many sewer manholes need to be coated for this project?

ANSWER: There is one receiving manhole located on Cate Road; 48" diameter x 10" depth.

5) QUESTION: What permits will be required for this project?

ANSWER: A Glynn County Right of Way permit is required for this work.

6) QUESTION: Is a GA Contractors License required to bid this project?

ANSWER: Yes, the Contractor must be licensed in the state of GA to bid on this project.

7) QUESTION: Bid items 9, 11, and 12 specify 8" DR11 HDPE FM by open cut, 12" DR11 HDPE casing by HDD, and 8" DR11 HDPE FM by HDD and slipline, respectively. Can 6" DR25 Fusible PVC pipe be approved in lieu of 8" DR11 HDPE? Additionally, can 10" DR25 Fusible PVC pipe casting with 6" Fusible PVC pipe carrier be approved in lieu of 12" DR11 HDPE?

ANSWER: No, no substitutions should be made to pipe type. This project coincides with Pump Station 4116 that is using HDPE and JWSC desires to keep the pipe types consistent.
