### **PROJECT DESCRIPTION**

The scope of work for this work includes furnishing all skill, labor, materials, tools, equipment and incidentals required to construct complete, in place, and ready to operate a new 10-inch force main along a portion of Oak Grove Road in Brunswick, Glynn County, Georgia including but not limited to tree removal; erosion and sedimentation controls; installation of force main by horizontal directional drilling and open cut construction; connection of force main to existing JWSC 10" FM; all Maintenance of Traffic including temporary pathway; all restoration work; and all other work and appurtenances required, the lump sum amount of. This work and bid include Driveway cuts and replacement in-kind per the approved plans at the time of bid, coordination for all driveway work, asphalt cutting, demolition, and replacement as shown in the plans.

Two alternates will also be considered for this bid:

#### Alternate #1

For furnishing all skill, labor, materials, tools, equipment and incidentals required to construct complete, in place, and ready to operate a new 4-inch force main along a portion of Oak Grove Road in Brunswick, Glynn County, Georgia including but not limited to tree removal; erosion and sedimentation controls; installation of force main by horizontal directional drilling and open cut construction; connection of force main to existing JWSC 10" FM; all Maintenance of Traffic including temporary pathway; all restoration work; and all other work and appurtenances required, the lump sum amount of. This work and bid include Driveway cuts and replacement in-kind per the approved plans at the time of bid, coordination for all driveway work, asphalt cutting, demolition, and replacement as shown in the approved plans at the time of bidding.

#### Alternate #2

For furnishing all skill, labor, materials, tools, equipment and incidentals required to construct complete, in place, and ready to operate a new 6-inch force main along a portion of Oak Grove Road in Brunswick, Glynn County, Georgia including but not limited to tree removal; erosion and sedimentation controls; installation of force main by horizontal directional drilling and open cut construction; connection of force main to existing JWSC 10" FM; all Maintenance of

Traffic including temporary pathway; all restoration work; and all other work and appurtenances required, the lump sum amount of. This work and bid include Driveway cuts and replacement in-kind per the approved plans at the time of bid, coordination for all driveway work, asphalt cutting, demolition, and replacement as shown in the plans.
