Chairman Turnipseed called the meeting to order at 2:00 PM.

Chairman Neal provided the invocation and Commissioner Duncan led the Pledge of Allegiance.

PUBLIC COMMENT PERIOD

Chairman Turnipseed opened the public comment period. There being no citizens for public comment, Chairman Turnipseed closed the public comment period.

COMMISIONERS SWEARING-IN CEREMONY – The Honorable Debra Godwin Duncan Kendra L. Rolle, Commissioner 2022-2023 City of Brunswick Commission Appointment Tripp Stephens, Commissioner 2022-2025 Grand Jury Appointment – Second Term

ELECTION OF OFFICERS

<u>Commissioner Stephens made a motion seconded by Commissioner Neal to reappoint Chairman</u> <u>Turnipseed as Chairman for 2022 and to reappoint Commissioner Duncan as Vice Chairman for 2022.</u> <u>Motion carried 7-0-0.</u>

COMMITTEE APPOINTMENTS

Chairman Turnipseed announced the appointments of the 2022 Communications, Economic Development, Facilities, Finance, Human Resources, Legislative, and Emergency Preparedness Committees to include Committee members and Committee Chairperson.

COMMITTEE UPDATES

Facilities Committee – Chairman Turnipseed

Chairman Turnipseed reported that the Facilities Committee had met the previous day at 1:00 p.m. The Chairman stated that the Committee reviewed and forwarded two items to the Full Commission for approval. Those items were a time extension for the GEFA loan and a Letter of Support to Georgia State Property Commission.

Finance Committee – Commissioner Duncan

Committee Chairman Duncan reported that the Finance Committee meeting was held on the previous day at 3:00 p.m. There was one item for approval to the Full Commission, the time extension for the GEFA loan. Commissioner Duncan mentioned that the JWSC was doing a good job spending SPLOST funds and staying on track for completing SPLOST projects. JWSC Accounting Manager, Frances Wilson gave an overview of the Financial Statements for December 2021.

APPROVAL

1. Minutes from the December 16, 2021 Regular Commission Meeting

Commissioner Cook made a motion seconded by Commissioner Duncan to approve the minutes from the December 16, 2021 Regular Commission Meeting. Motion carried 6-0-1. (Commissioner was absent for the vote).

2. Minutes from the December 16, 2021 Executive Session

Commissioner Duncan made a motion seconded by Commissioner Stephens to approve the minutes from the December 16, 2021 Executive Session. Motion carried 6-0-1 (Commissioner Neal was absent for the vote).

3. GEFA Loan Time Extension – A. Burroughs

Mr. Burroughs presented a request for a time extension approval on the BGJWSC GEFA loan for improvements to the Academy Creek WPCF and the gravity sewer system in the amount on \$15,000,000. Due to impacts from COVID-19 and supply delays on materials associated with the projects, the Project has experience significant supply chain and delivery delay issues, which have subsequently impacted the project schedule and timeline. Time extension is the only change to the original terms and conditions of the loan. Commissioner Cook asked Mr. Burroughs about the reason for screen delivery delays to Academy Creek WPCF. Mr. Burroughs explained that those delays are due to COVID-19 and component delays as the screens do not come assembled.

Commissioner Neal made a motion seconded by Commissioner Strickland to move that the Brunswick-Glynn Joint Water and Sewer Commission approve the modification for time extension for GEFA Loan CW2019008.

Motion carried 7-0-0.

4. Letter of Support to Georgia State Property Commission – A. Burroughs

Mr. Burroughs presented a Letter of Support for Morningstar Children and Family Services for the release of the State of Georgia's reversionary interest in Morningstar's real property in Glynn County. Mr. Burroughs explained that there is mutual interest between Morningstar and the JWSC for the JWSC purchase of a portion of the unimproved acreage owned by Morningstar for the construction of water and sewer infrastructure to benefit residents and businesses in northern Glynn County. The state of Georgia currently holds reversionary interests in the Morningstar campus that prevents the sale of any property to the JWSC. Morningstar has petitioned the State of Georgia to release their reversionary interests, requiring a letter signed by each JWSC Commissioner. The letter is to be submitted to the Georgia State Property Commission in the hopes that the reversionary interests would be released during the current state legislative session. Commissioner Cook inquired as to the price and acreage of the land JWSC wished to purchase from Morningstar. Mr. Burroughs stated that the price was currently undetermined, but that the acreage was approximately 15 acres. Commissioner Strickland requested that Mr. Burroughs supply the Commissioners with similar Letters of Support from other Glynn County agencies, including the Glynn County Commission. Commissioner Duncan stated that this property acquisition would be an excellent source of growth for the JWSC and the North Mainland area of Glynn County.

<u>Commissioner Duncan made a motion seconded by Commissioner Neal to move that the Brunswick-</u> <u>Glynn Joint Water & Sewer approve the submission of a Letter of Support for Morningstar Children and</u> <u>Family Services, Inc., for the release of the State of Georgia's reversionary interest in Morningstar's real</u> <u>property in Glynn County.</u>

Motion carried 7-0-0.

DISCUSSION

There were no items for discussion.

EXECUTIVE DIRECTOR'S UPDATE

Mr. Burroughs congratulated Commissioners Rolle and Stephens on their appointment and reappointment to the JWSC Commission. He also updated the Commission on the status of the Low Income Household Assistance Program that was approved by the Commission during the December 2021 meetings. To date the JWSC has had 52 customers take advantage of the program at an amount of \$26,080. Customers can visit the Coastal Georgia Community Action Authority to determine their eligibility and receive a voucher for the program if approved. Mr. Burroughs welcomed Executive Commission Administrator Janice Meridith back from medical leave and thanked Christa Free for filling in during Ms. Meridith's absence.

There were no items any other Commissioner wished to discuss.

Chairman Turnipseed thanked the Commissioners for a productive retreat meeting held at the offices of Hall, Booth, Smith on Wednesday, January 19, 2022.

Background

On September 19, 2019 the Commission approved a Georgia Environmental Finance Authority ("GEFA") loan in the amount of fifteen million (\$15,000,000) dollars for improvements to the Academy Creek WPCF as well as the gravity sewer systems (the "Project"). The original loan documents showed repayment of the loan commencing on February 1, 2022.

Staff Report

Due to the impacts of COVID on the construction industry and associated materials suppliers, the Project has experienced significant supply chain issues and delayed delivery schedules. These issues have likewise impacted the project schedule. As a result, JWSC has submitted an official request to GEFA for an extension of time to commence loan repayments. GEFA has provided documents for approval of this loan modification with an accompanying requirement that JWSC provide confirmation of the Board's support for this change in the form of the attached Resolution. Aside from the time extension there are no changes to the original loan terms and conditions.

Recommended Action

Staff recommends that the full Commission approve the loan modification for time extension in the form of the attached Resolution (Exhibit "F"). The Finance Committee reviewed and referred this item to the full Commission on January 19, 2022.

MODIFICATION OF PROMISSORY NOTE AND LOAN AGREEMENT

THIS MODIFICATION OF PROMISSORY NOTE AND LOAN AGREEMENT (this "Modification") dated ______, 20____, by and between BRUNSWICK-GLYNN COUNTY JOINT WATER & SEWER COMMISSION, Georgia, a Georgia public body corporate and politic (the "Borrower"), and the CLEAN WATER STATE REVOLVING FUND, ADMINISTERED BY GEORGIA ENVIRONMENTAL FINANCE AUTHORITY, a Georgia public corporation (the "Lender").

Statement of Facts

A. The Lender and the Borrower are parties to that certain Loan Agreement, dated **JUNE 12, 2020**, as amended prior to the date hereof (as so amended, the "Loan Agreement"; all capitalized terms used in this Modification but not defined herein have the meanings given in the Loan Agreement), pursuant to which the Lender made a loan to the Borrower in accordance with the terms and conditions thereof. The Borrower's obligation to repay such loan is evidenced by that certain Promissory Note, dated **MAY 21, 2020**, as amended prior to the date hereof (as so amended, the "Note").

B. The Lender and the Borrower desire to modify the Loan Agreement and Note in certain respects in accordance with the terms and conditions set forth herein.

NOW, THEREFORE, in consideration of the promises, the covenants and agreements contained herein, and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Lender and the Borrower further agree as follows:

Statement of Terms

1. <u>Amendments of Note</u> - Subject to the fulfillment of the conditions precedent to the effectiveness of this Modification that are set forth below, the Note is hereby amended as follows:

Accrued interest on this Note shall be payable monthly on the first day of each calendar month until the first day of the calendar month following the earlier of (1) the Completion Date (as defined in the hereinafter defined Loan Agreement), (2) **NOVEMBER 1, 2022**, or (3) the date that the loan evidenced by this Note is fully disbursed (the "Amortization Commencement Date"). Principal of and interest on this Note shall be payable in **TWO HUNDRED FIFTY-NINE (259)** consecutive monthly installments equal to the Installment Amount (as hereinafter defined), commencing on the first day of the calendar month following the Amortization Commencement Date, and continuing to be due on the first day of each succeeding calendar month thereafter, together with a final installment equal to the entire remaining unpaid principal balance of and all accrued interest on this Note, which shall be due and payable on the date that is **30** years from the Amortization Commencement Date (the "Maturity Date").

2. <u>Amendments of Loan Agreement</u> - Subject to the fulfillment of the conditions precedent to the effectiveness of this Modification that are set forth below, the Loan Agreement is hereby amended as follows:

Section 2 (a) of the Loan Agreement is hereby amended and restated to read as follows: "The Lender agrees to advance to the Borrower, on or prior to the earlier of (1) the Completion Date (as hereinafter defined), (2) **NOVEMBER 1, 2022**, or (3) the date that the loan evidenced by this Note is fully disbursed, the Loan in a principal amount of up to **\$15,000,000** which Loan may be disbursed in one or more advances but each such disbursement shall reduce the Lender's loan commitment hereunder and any sums advanced hereunder may not be repaid and then re-borrowed."

Exhibit A is amended and restated to read as written in the attached Exhibit A.

3. <u>No Other Waivers or Amendments</u> - Except for the amendments expressly set forth and referred to in Section 1 and 2 above, the Note and the Loan Agreement shall remain unchanged and in full force and effect. Nothing in this Modification is intended, or shall be construed, to constitute a novation or an accord and satisfaction of any of the obligations created by the Note.

4. <u>Representations and Warranties</u> - To induce the Lender to enter into this Modification, the Borrower does hereby warrant, represent, and covenant to the Lender that: (a) each representation or warranty of the Borrower set forth in the Loan Agreement is hereby restated and reaffirmed as true and correct on and as of the date hereof as if such representation or warranty were made on and as of the date hereof (except to the extent that any such representation or warranty expressly relates to a prior specific date or period), and no Event of Default has occurred and is continuing as of this date under the Loan Agreement; and (b) the Borrower has the power and is duly authorized to enter into, deliver, and perform this Modification, and this Modification is the legal, valid, and binding obligation of the Borrower enforceable against it in accordance with its terms.

5. <u>Conditions Precedent to Effectiveness of this Modification</u> - The effectiveness of this Modification is subject to the truth and accuracy in all material respects of the representations and warranties of the Borrower contained in Section 4 above and to the fulfillment of the following additional conditions precedent:

a. the Lender shall have received one or more counterparts of this Modification duly executed and delivered by the Borrower; and

b. the Lender shall have received (1) a signed opinion of counsel to the Borrower, substantially in the form of Exhibit E attached hereto, and (2) a certified copy of the resolution adopted by the Borrower's governing body, substantially in the form of Exhibit F attached hereto.

6. <u>Counterparts</u> - This Modification may be executed in multiple counterparts, each of which shall be deemed to be an original and all of which when taken together shall constitute one and the same instrument.

Background

Morningstar Children and Family Services, Inc. owns a 125+ acre campus off Highway 99 in north Glynn County. At the campus, Morningstar provides residential and community counseling services to children, youth, and their families. They provide homes for developmentally delayed youth and provide counseling services to traumatized and abused youth from across the state. There is mutual interest between Morningstar and the JWSC for the JWSC purchase of a portion of the unimproved acreage owned by Morningstar for the construction of water and sewer infrastructure to benefit the residents and businesses in northern Glynn County.

Staff Report

Currently, the State of Georgia holds reversionary interests in the Morningstar campus that prevents the sale of the property to the JWSC. Morningstar has petitioned the State of Georgia to release these reversionary interests to further aid the public missions of both Morningstar and the JWSC. The attached letter of support would be submitted to the Georgia State Properties Commission with the hope that the reversionary interests would be released during the current State legislative session. This item was presented to the Facilities Committee on January 19, 2022.

Recommended Action

Staff recommends the Commission authorize each Commissioner to sign the attached letter of support and to submit to the Georgia State Properties Commission.

We write to convey our support of the pending request by Morningstar and JWSC regarding the State of Georgia's release of its reversionary interest in Morningstar's real property in Glynn County, Georgia. It is our understanding that Morningstar is petitioning the State Properties Commission to obtain a release of the State's reversionary interests in Morningstar's real property in Glynn County, Georgia. The request would further aid the public missions of both Morningstar and JWSC and further benefit the State of Georgia. For the reasons below, we urge you to support their request and facilitate the approval of the State's conveyance of its interest in the upcoming session of the General Assembly.

Morningstar is a 501(c)(3) tax exempt nonprofit organization founded in 1996 to provide residential and community counseling services to children, youth, and their families. Morningstar provides homes for developmentally delayed youth and provides counselling services to traumatized and abused youth from across the state. As part of that mission, Morningstar operates the Youth Estate Campus (the "Campus"), a residential care and counselling facility. The Campus consists of approximately 25 acres located in north Glynn County off Highway 99 at 235 Santo Domingo Drive, Brunswick. Adjacent to the Campus, Morningstar owns approximately 100 + acres of unimproved upland (the "Additional Property") that it uses to support its mission with outdoor recreational opportunities.

JWSC is a body corporate and politic serving and safeguarding the public health and safety of Brunswick and Glynn County through the provision of drinking water and environmentally responsible wastewater treatment services and facilities. Organized by act of the General Assembly in 2006 (HB 1585; Act 448 2006), JWSC has as its mission "acquiring, constructing, equipping, maintaining, and operating adequate water supply, treatment, and distribution facilities and sewerage collection, treatment, and distribution facilities . . . and extending and improving such facilities as necessary." In creating the JWSC, the General Assembly saw fit to declare that properties held by JWSC, are "public properties used for the benefit and welfare of the people of the city and county."

Granting Morningstar's request would further enable the public purposes of both Morningstar, which provides homes and counselling services to our State's most vulnerable, and JWSC, which provides clean drinking water and public sewer and water treatment services to property owners and residents in Brunswick and Glynn County. It is our understanding that the State has previously released a similar interest in Morningstar's campus some years ago.

We urge you to support Morningstar's request and to encourage its approval by the General Assembly in the upcoming legislative session. Please let us know if you have any questions or if we can provide further information.
