**PROJECT: INVITATION FOR BID NO. 22-024 ON-CALL BORING
SERVICES FOR THE BGJWSC**

**THIS ADDENDUM IS FOR THE PURPOSE OF ANSWERING THE FOLLOWING
QUESTIONS:**

1) QUESTION: Will there be a line item added to the bid tab for mobilization?

ANSWER: No. Please include mobilization in the line item cost for each requested service.

2) QUESTION: What percent is the bid bond for this solicitation?

ANSWER: Because this is a solicitation for on-call services (job order contract), the size of these individual jobs should not approach the \$100,000 threshold for bonding required by the state of GA.

3) QUESTION: Is there a bid bond form required or should the contractor use a AIA form?

ANSWER: Please see Question 3 of this addendum. We do not anticipate reaching the bid bond threshold for this contract.

4) QUESTION: Will there be liquidated damages on this solicitation?

ANSWER: The intention is to not have liquidated damages on this solicitation. The

documents request a 3-week turn-around on services once materials have been secured by the JWSC. Because of the small nature of the individual jobs the JWSC does not anticipate unforeseen circumstances that would fall under liquidated damages.

5) **QUESTION:** What is the term/length of the contract?

ANSWER: The JWSC would like to have pricing held for a 6-month minimum and will use individual Purchase Orders for each of the jobs to authorize and initiate work.

6) **QUESTION:** Is this for all bores the JWSC might have a need for or just emergency situations that arise?

ANSWER: This contract will be for smaller jobs, typically something our Water Distribution department needs to complete in a short amount of time in response to repairs. Boring work that is part of a major capital project will continue to be included with the overall project bid for those solicitations.

7) **QUESTION:** Are the boring services being requested for emergency bores or for scheduled borings?

ANSWER: Please refer to Question 6 of this addendum

8) **QUESTION:** If these boring services are for emergency services, what is the minimum response time?

ANSWER: The JWSC does not envision this contract being used for emergency services. Should that need arise, the JWSC would contract separately for those services.

9) **QUESTION:** What is the length of each bore as requested?

ANSWER: Bore lengths will vary based on the job.

10) **QUESTION:** Where are the locations for the boring services as being requested?

ANSWER: The areas will be located in Brunswick and St. Simons Island, but will not be known specifically until there is a need for the services

11) **QUESTION:** Does the JWSC want the mobilization/demobilization and travel cost in each line item or shown separate for each line item?

ANSWER: Please refer to Question #1 of this Addendum.

12) QUESTION: Would any of these borings be for railroads, water crossings, DOT right-of-ways, or major intersections? If so, please identify.

ANSWER: Not that the JWSC is aware of.

13) QUESTION: Is the JWSC looking for these prices to be for a period of time or is this one time pricing?

ANSWER: Period of time.

14) QUESTION: What is the time frame for this project per bore location?

ANSWER: JWSC would like work to be completed at each job in 1 to 2 days.

15) QUESTION: What is the depth of these borings as requested?

ANSWER: Depths will vary from 3ft to 5ft.

16) QUESTION: Are any of these boings for gravity sewer?

ANSWER: No.
